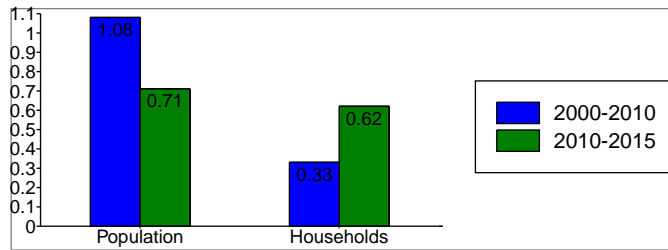

**Population and Households**

The size of the market area, measured by population and households, has changed from 2000 through the forecast year as follows:

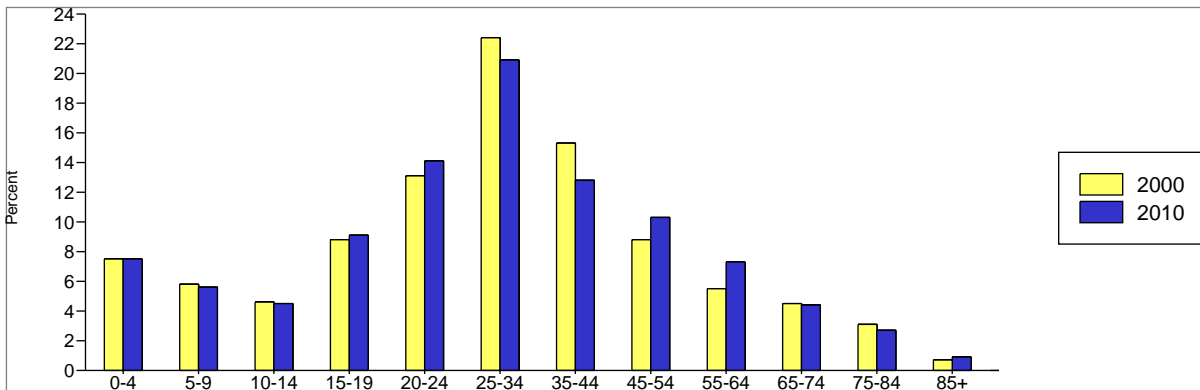

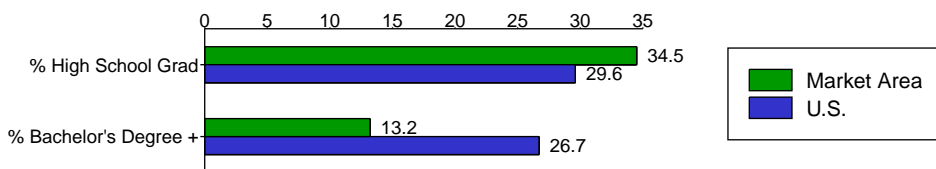
**Population by Age**

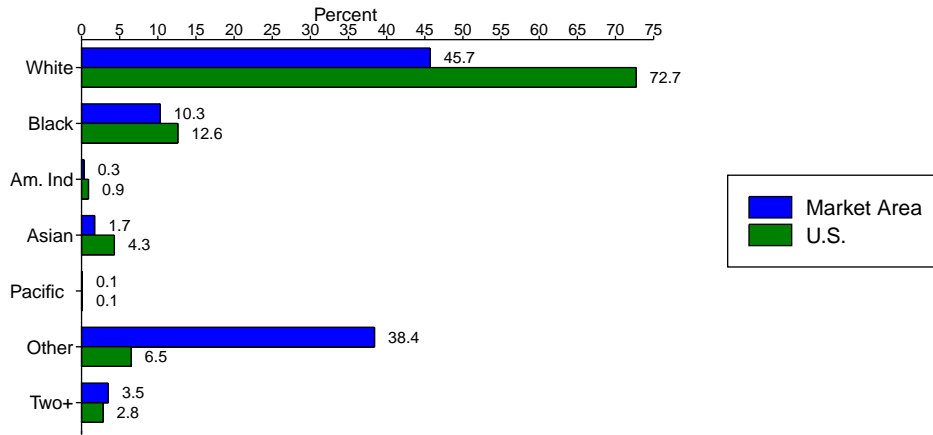

Currently, the racial composition of the population in the market area breaks down as follows:

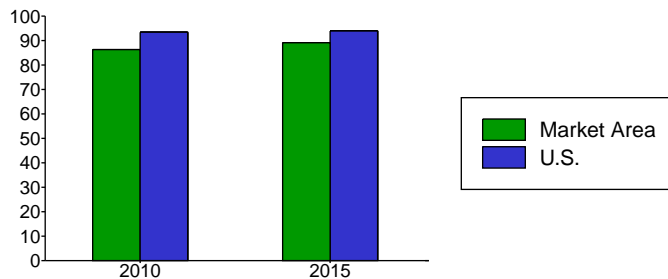


Persons of Hispanic origin represent 54.2 percent of the population in the identified market area compared to 15.0 percent of the U.S. population. Persons of Hispanic Origin may be of any race. In sum, the Diversity Index, which measures the probability that two people from the same area will be from different race/ethnic groups, was 88.9 in the identified market area, compared to 59.3 in the U.S. population.

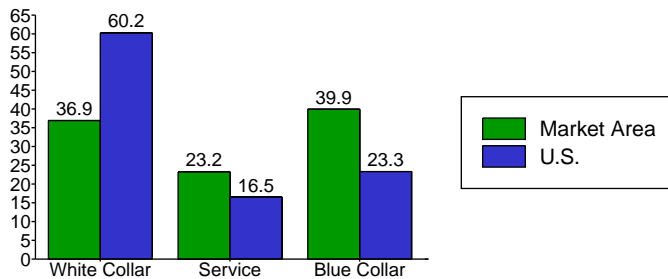
**Population by Employment**

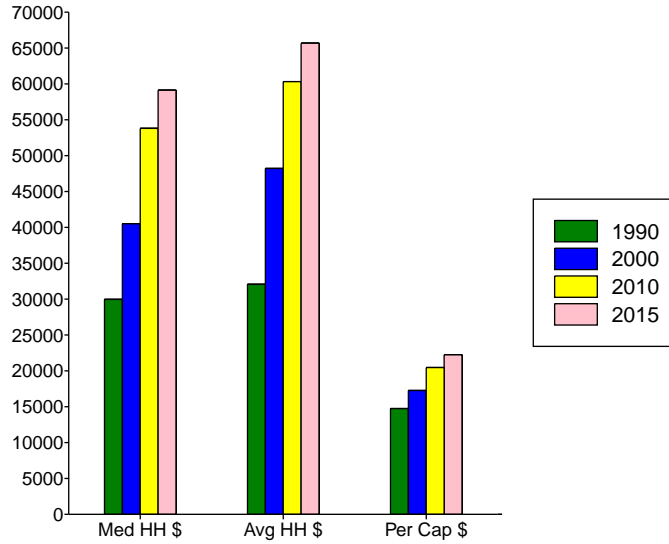

**Housing**

Currently, 32.5 percent of the 1,131 housing units in the market area are owner occupied; 58.4 percent, renter occupied; and 9.1 percent are vacant. In 2000, there were 1,063 housing units— 34.4 percent owner occupied, 58.9 percent renter occupied and 6.7 percent vacant. The annual rate of change in housing units since 2000 is 0.61 percent. Median home value in the market area is \$122,606, compared to a median home value of \$192,285 for the U.S. In five years, median home value is projected to change by 2.68 percent annually to \$139,923. From 2000 to the current year, median home value changed by 2.77 percent annually.

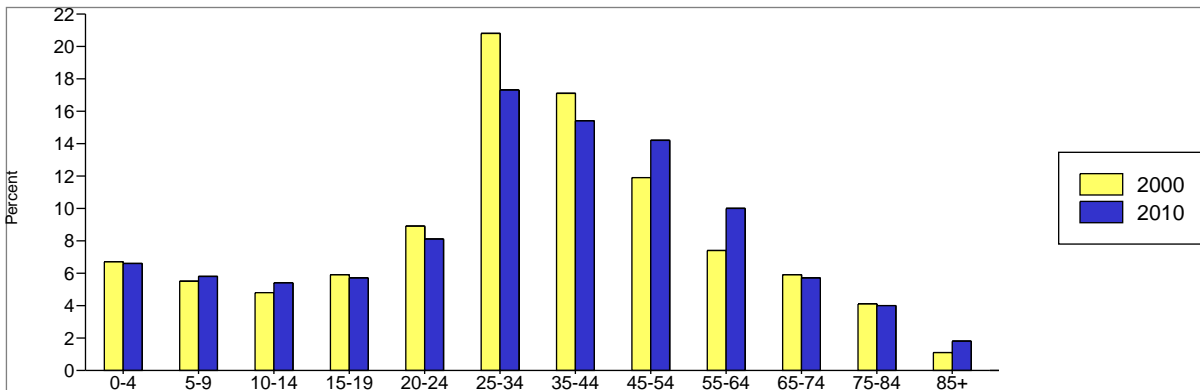

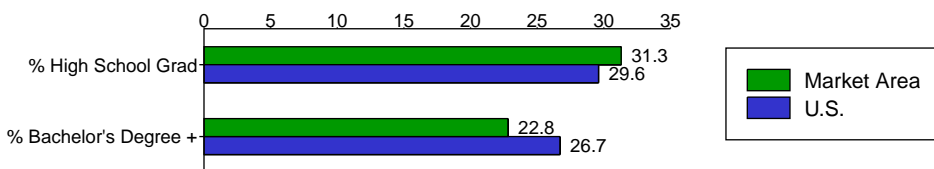

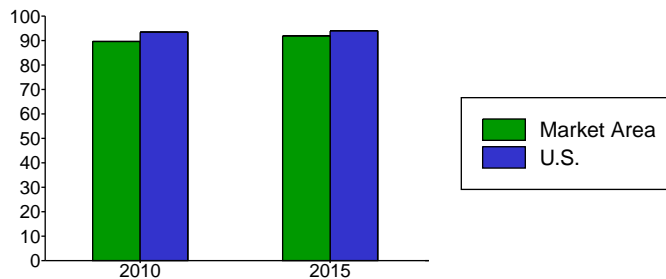

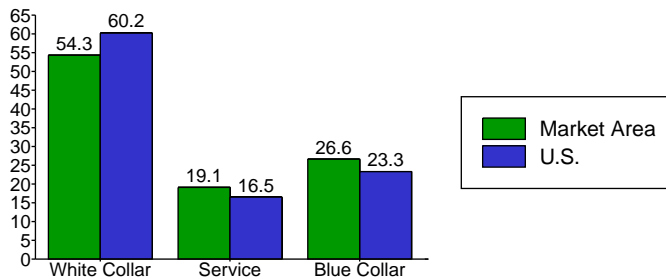

**Housing**

Currently, 43.8 percent of the 18,214 housing units in the market area are owner occupied; 48.2 percent, renter occupied; and 8.0 percent are vacant. In 2000, there were 16,982 housing units—46.5 percent owner occupied, 48.4 percent renter occupied and 5.1 percent vacant. The annual rate of change in housing units since 2000 is 0.69 percent. Median home value in the market area is \$120,782, compared to a median home value of \$192,285 for the U.S. In five years, median home value is projected to change by 2.82 percent annually to \$138,826. From 2000 to the current year, median home value changed by 2.56 percent annually.

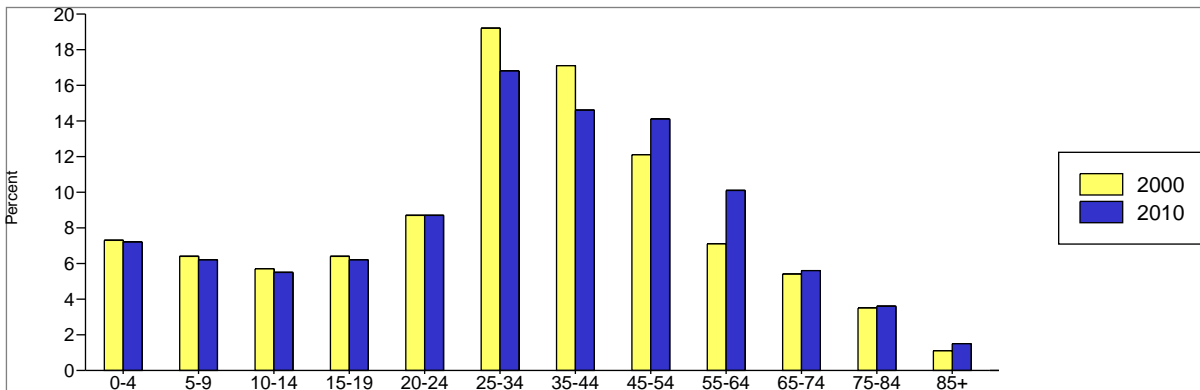

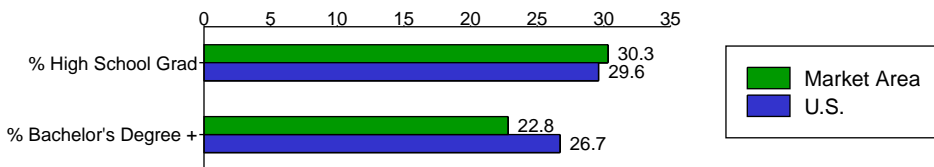

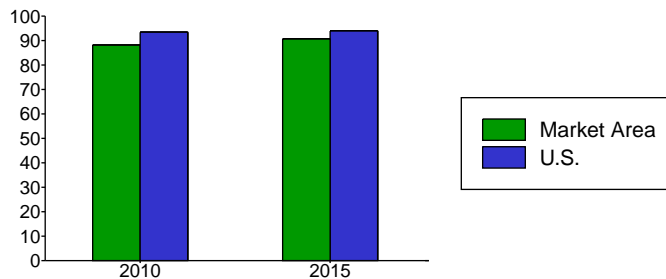

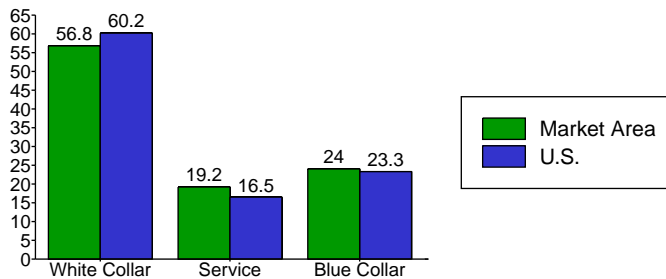

**Housing**

Currently, 41.6 percent of the 67,177 housing units in the market area are owner occupied; 49.1 percent, renter occupied; and 9.3 percent are vacant. In 2000, there were 61,360 housing units— 43.9 percent owner occupied, 50.0 percent renter occupied and 6.1 percent vacant. The annual rate of change in housing units since 2000 is 0.89 percent. Median home value in the market area is \$118,564, compared to a median home value of \$192,285 for the U.S. In five years, median home value is projected to change by 2.8 percent annually to \$136,105. From 2000 to the current year, median home value changed by 2.6 percent annually.
